

# PETERBOROUGH ROYAL FOXHOUND SHOW SOCIETY

How to renew your membership to the Peterborough Royal Foxhound Show Society.

Subscriptions enable the Peterborough Royal Foxhound Show Society to carry on and expand its work to promote the interest of Foxhound breeding in the United Kingdom.

In addition to being a subscribed member Vice Presidents' also receive the following by returning the 2025 show booking form sent out in April.

- A named badge which admits the badge holder to the Peterborough Royal Foxhound Show held in July together with the Festival of Hounds which incorporates the Association of Masters of Harriers and Beagles Show and the Association of Masters of Basset Hounds Show.
- A reserved named seat in the Foxhound Enclosure.
- The right to purchase extra badges for guests which admit to the Hound Show and to a reserved named seat within the Fitzwilliam Hound Enclosure.
- To purchase tickets for the Vice Presidents' luncheon.

**Each Spring, subscribed Vice Presidents are then sent a show booking form for confirming reserved seating, details on the Vice Presidents' luncheon and an application for additional guest tickets.**

**Please note:** Only by returning the show booking form will Vice Presidents then receive their named badge, entrance ticket and one complimentary car pass.
